- 5.) Must provide an academic transcript.

- 7.) To be considered for a financial needs scholarship, please provide a copy of your FAFSA confirmation page that includes your Expected Family Contribution (EFC).
- 8.) Immediate relatives* of Marblehead Bank employees and Board of Trustees are ineligible. (*Immediate relative includes: children, grandchildren, stepchildren and siblings)

All of the above criteria will be evaluated when determining the recipients.
