Joint meeting with the Selectboard to interview applicants for vacancy on School Committee.

The Town Administrator called the meeting to order at 7pm. The following roll call vote was taken: Mrs. Singer, present (remotely); Mrs. Noonan, present (remotely); Mr. Nye, present; Mrs. Belf-Becker, present; Mr. Grader, present.

The Chair of the School Committee, Ms. Sarah Fox called the school committee portion of the meeting to order at 7:01pm. All members were present. No roll call was required.

The Board met in joint session with School Committee members Sarah Fox, Chair, Sarah Gold, Meagan Taylor and Alison Taylor, in accordance with MGL Chapter 41 §11 and Marblehead School Committee policy BBBE, to fill a vacancy on the school committee. Chair Grader welcomed the candidates to the meeting and gave a brief outline for the interview process. The following applicants were interviewed: Paul Baker, Don DeWitt, Raymond Hanson, Thomas Mathers, Liam McGeown, Scott Stunkel.

The Chair called for a 5-minute recess at the completion of the interviews.

After returning from recess, a motion made and seconded to place all applicants' names in for nomination. The motion was moved by Mrs. Noonan. The board and committee members made various comments and thanked all applicants for stepping up and encouraged all to stay engaged in the Town. The Town Administrator outlined the procedure for voting sharing that a majority vote is required to appoint a new member. Additionally, it was explained that if a majority is not received on the first round the applicant with the least number of votes will be eliminated and a 2nd round of voting will take place with additional rounds to follow until a majority is received.
