**I. Initial Business and Public Involvement**

**1. Call to Order**

Ms. Gold called the meeting to order at 6:33pm.

**II. School Communication and Discussion Items**

**1. Approval of Policy Changes**

Ms. Gold informed the committee that both of the policies on the agenda were recently looked at during a policy subcommittee meeting scheduled on Friday September 4<sup>th</sup>.

**a. Sexual Harassment Policy-Policy ACAB**

Superintendent Buckey explained that policy ACAB which discussed sexual harassment was being updated to accommodate for changes to the Title XI reporting processes and procedures at the federal level sharing that national policies affected local ones. It was mentioned that a vote would be required at the meeting scheduled on September 17<sup>th</sup>.

Ms. Gold read part of the policy aloud until Mr. Harris confirmed that the district policy for reviewing and revising policies (policy BGC) did not require a public reading of the policy. He further clarified as the policy referenced that 1) information would need to be provided, 2) a policy discussion needed to take place and 3) action items such as an adoption or rejection of the discussed policy needed to occur.

Although no formal vote was taken, it was decided that Ms. Gold could refrain from reading the remaining pages in the policy and move on to discuss the next agenda item.

**b. Approval of Supplemental Policies on COVID -related issues (Policy EBC Supplemental)**

Ms. Gold explained that the EBC policy would be adopted for the time of COVID and would be rescinded once it was no longer needed. She further shared that approving just one policy instead of the more than thirty (30) policies that could be affected by COVID would make the process easier in the long run.

Ms. Gold noted that the policy would be voted on at the meeting on the 17<sup>th</sup>.

**2. Approval of Handbooks**

Ms. Gold reminded the committee that the vote to approve the handbooks was tabled to allow for more time to understand the COVID related policy issues that could affect school attendance at the high school. She explained that the vote would be to approve the Pre-K, Veterans and the High School Handbooks.

Ms. Gold made a motion to accept the high school handbook changes for the 2020 and 2021 school year as well as the changes for the Pre-k through 6<sup>th</sup> and the Veterans handbook. The motion was moved by Ms. Taylor and seconded by Ms. Barron. A roll call vote was taken and the motion carried, 5-0 all in favor.

### **3. Approval of Memorandum of Agreement with the Marblehead Education Association**

Ms. Gold asked for a motion to approve and accept the memorandum of agreement with the Marblehead Education Association for the reopening of schools. The motion was moved by Ms. Taylor and seconded by Ms. Barron.

Ms. Fox voiced her concerns regarding staff spacing concerns and her feelings regarding remote approval to work from home which could allow for more than ample staff spacing.

Both Ms. Gold and Mr. Harris agreed that all space considerations had been investigated and addressed through multiple building walkthroughs and planning.

Superintendent Buckey praised the staff for making the return to school during such a difficult time feel special and inviting.

A discussion regarding the childcare section of the agreement took place and it was agreed that it was an important part of the agreement that staff would appreciate.

A roll call vote was taken and the motion passed, 5-0 all in favor.
