#### II. Consent Agenda & Action Items

#### 1. Minutes: 8/1/2018

Ms. Schaeffner made motion to approve the minutes of 8/1/2018. The motion was seconded by Ms. Gold and the Committee **VOTED** unanimously, 5-0, in favor.

#### **Minutes: 9/6/18**

Ms. Gold noted that a request to add a statement that was made at that meeting should be included as part of the approval of the minutes. Under Gerry Warrant Article, include statement: "Ms. Schaeffner reminded the community that the decision of what is to be done with the building will be done at the Town meeting."

Mr. Harris made motion to approve the minutes of 9/6/2018 with the addition of the statement. The motion was seconded by Ms. Taylor and the Committee **VOTED** unanimously, 5-0, in favor.

### III. Teaching/Learning-Superintendent of Schools

A. District Reports and Updates

#### 1. Community Service-High School

Dan Bauer, principal at MHS, introduced Mr. Ron Grenier who has been involved in this Service Learning project at the high school by putting together a center of community engagement. Mr. Bauer noted that in the near future, we will create a day of service where the students go into the community and give back to the community. Last year two students did this for a senior project and created a catalog of community service opportunities. This year, on October 24<sup>th</sup> from 8-12, our Freshman will go out to 14 different sites or projects in and around Marblehead and will return for a reflection piece after the day of service.

### 2. ALICE update

Dr. Perry stated that most administrators were trained as trainers in the ALICE protocol. On October 9<sup>th</sup> there will be a full day for the entire staff and faculty on ALICE protocol. By October 29<sup>th</sup> we hope to invite parents and community to explain this protocol which will then be presented to the students.
