I. Initial Business

A. Call to Order

Ms. Tedford called the meeting to order at 7:00pm. She informed the public that the Committee will not be making any decisions during this forum. She also noted that the next School Committee meeting will be held on Wednesday, September 13th where this item will appear on the agenda.

Ms. Tedford stated that this evening's forum is to discuss the proposal regarding the parking lot signage at the Gerry School which currently states that it is reserved for school use from 6:00am to 4:30pm. Mr. Magee's proposal would change the signage to read *until the street lights come on*. Ms. Tedford also stated that the Police and Fifire chiefs, the Superintendent, the Facilities Director, and the Principal have all had input on this issue and agree with the Superintendent's decision to not change the signage. Ms. Tedford then opened the forum to the public and asked the first person on the list of speakers to come up.

Bill Smalley, 22 Prospect Street spoke on behalf of the Unitarian Universalist Church of Marblehead, which has used the parking lot for Sunday services, funerals, weddings and other special services for years. He noted that they have a parking attendant for events and would like to have the same arrangement continue with the schools.

Jody Magee, 13 Guernsey Street. He has no problems with members of community using the playground. His goal is to set hours from 6am until the street lights go on. He asked to have a statement in the Church bulletin that would state that as good neighbors, the school department allows us to park in their playground and could you worshipers please not get there before the hours of worship. He is asking for the parking situation to be amended so the young children in the area could have more time on the playground and said the sign would be a deterrent to having people park in lot.

Superintendent Perry made the public statement that she does not support the statement that Mr. Magee is asking of the Unitarian Universalist Church.

Mr. Harris asked Mr. Magee to restate what he was proposing. Mr. Magee said that his request is to change the signage to read from 6am until the street lights come on.
